Application to Amend an Industrial Hemp Licence (Extension of Licence Period)

Misuse of Drugs (Industrial Hemp) Regulations 2006

INFORMATION FOR APPLICANTS

- This application form is used by a licensee, before the expiry of a licence, to apply to the Director-General for an extension to the licence expiry date, pursuant to regulation 22 of the Misuse of Drugs (Industrial Hemp) Regulations 2006.
- No extension may be granted that would result in a licence being in force for more than 3 years after the date of its issue.
- Where a decision is made to extend an industrial hemp licence that authorises cultivation of industrial hemp, the licence will be extended for a period not exceeding 12 months.
- For the application to be considered, all sections of the application form must be completed by a
 responsible person named on the current licence, and received by Medsafe at least 12 weeks before the
 expiry date of the current licence.
- For each licence, only one application to amend the licence can be in progress at a time (a licensee cannot submit a further application to amend the licence whilst an application to amend the licence is already in progress).
- During assessment of the application further information may be requested from the applicant.
- Information provided in the application may be shared with other agencies including the New Zealand Police and the Ministry for Primary Industries.

APPLICATION FEE

• There is no application fee payable when applying to extend the expiry date of an existing industrial hemp licence.

APPLICATION FORM SUBMISSION

- This application form can be completed electronically using a pdf reader. The current version of Adobe Reader, available free of charge from the Adobe website (https://get.adobe.com/reader) is recommended.
- The completed application form should be emailed to Medsafe (industrialhemp@health.govt.nz), with any additional supporting documents attached in the email. Applicants must ensure that the emailed form is complete. The original electronic form should be retained for the applicant's records.
- Whilst the submission of applications by email is encouraged, applications are also accepted by post. A copy of the form should be retained for the applicant's records.
