- (2) In this notice, the Primary Maternity Services Notice 2007, which was published as a Supplement to the *New Zealand Gazette*, 13 April 2007, No. 41, page 1025 and became effective from 1 July 2007, is called the "principal notice".
- **2. Commencement**—This notice comes into force on 1 March 2016.
- **3. Amendment** The principal notice is amended by revoking Schedule 1 and substituting the new Schedule 1 set out in the Schedule to this Notice.

4. Transitional provision relating to implementation of amendment—

- (1) The default transitional provisions in clause A12 of the principal notice apply to this amendment.
- (2) For the purposes of applying the default transitional provisions, the implementation date for this amendment is 1 July 2015.
