#### Palm Tree Healthcare Limited - Palm Tree Rest Home

#### Introduction

This report records the results of a Certification Audit of a provider of aged residential care services against the Ngā Paerewa Health and Disability Services Standard (NZS8134:2021).

The audit has been conducted by BSI Group New Zealand Ltd, an auditing agency designated under section 32 of the Health and Disability Services (Safety) Act 2001, for submission to the Ministry of Health.

#### General overview of the audit

Palm Tree Rest Home provides services for rest home level care for up to 28 residents. There were 13 residents on the day of audit.

This certification audit was conducted against the Ngā Paerewa Health and Disability Services Standard 2021 and the contracts with Te Whatu Ora Health New Zealand - Waitematā. The audit process included the review of policies and procedures, the review of residents and staff files, observations, and interviews with, residents, families/whānau, management, staff, and the general practitioner.

The manager is a registered nurse and is one of three owners of Palm Tree Rest Home. The owners are members of a group of business partners who own four aged care facilities in Auckland. They have owned the facility since July 2022. The manager is supported by a stable team of skilled healthcare assistants and non-clinical staff.

Feedback from residents and families was positive about the care and the services provided. An induction and in-service training programme are in place to provide staff with appropriate knowledge and skills to deliver care. A comprehensive ongoing education plan is implemented.

This certification audit identified the service meets the intent of the standard.

### Ō tatou motika | Our rights

Includes 10 subsections that support an outcome where people receive safe services of an appropriate standard that comply with consumer rights legislation. Services are provided in a manner that is respectful of people's rights, facilitates informed choice, minimises harm, and upholds cultural and individual values and beliefs.



Palm Tree Rest Home provides an environment that supports resident rights and safe care. They embrace Māori culture, beliefs, traditions and te reo Māori. Staff demonstrated an understanding of residents' rights and obligations. The service works to provide high-quality and effective services and care for all its residents. There is a Māori and Pacific health plan in place. Māori and Pacific advocates are available to residents.

Residents receive services in a manner that considers their dignity, privacy, and independence. Services and support are provided in a way that is inclusive and respects the residents' identity and their experiences. Staff listen and acknowledge the voices of the residents and effectively communicate with them about their choices. Care plans accommodate the choices of residents and their family/whānau. There is evidence that residents and family are kept informed. The rights of the resident and/or their family to make a complaint is understood, respected, and upheld by the service. Complaints processes are followed, and complaints and concerns are actively managed and documented.

### Hunga mahi me te hanganga | Workforce and structure

Includes 5 subsections that support an outcome where people receive quality services through effective governance and a supported workforce.



The business, quality, risk, and management plan includes a mission statement, values, and operational objectives. The service has effective quality and risk management systems in place that take a risk-based approach. These systems are in place to meet the needs of residents and staff. Quality improvement projects are implemented. Internal audits, meetings, and the collection and

collation of data were all documented as taking place as scheduled, with a corrective process implemented where applicable. Health and safety processes are in place, led by the manager. Health and safety is a regular agenda item in all staff and management meetings. Contractors and staff are orientated to health and safety processes.

There is a staffing and rostering policy. Safe staffing levels are provided. Human resources are managed in accordance with good employment practice. An orientation programme and regular staff education and training are in place.

The service ensures the collection, storage, and use of personal and health information of residents and staff is secure, accessible, and confidential.

## Ngā huarahi ki te oranga | Pathways to wellbeing

Includes 8 subsections that support an outcome where people participate in the development of their pathway to wellbeing, and receive timely assessment, followed by services that are planned, coordinated, and delivered in a manner that is tailored to their needs.



The service promotes equity of access to their facility through a well-documented entry and decline process. There is admission information available to residents and families prior to or on entry to the service. The manager, who is a registered nurse, assesses, plans, reviews and evaluates residents' needs, outcomes, and goals with the resident and their family/whānau and is responsible for each stage of service provision. The care plans demonstrate service integration. There is a plan in place for the manager to review assessments and care plans every six-months, or more often if health needs change. The organisation uses a c based resident file management system and an electronic medication management system. Resident files include medical notes by the general practitioner and allied health professionals.

The diversional therapist who is an owner, the activities coordinator and health care assistants provide and implement a wide variety of activities which include cultural celebrations. The programme includes community visitors and outings, entertainment and activities that meet the individual recreational, physical, cultural, and cognitive abilities and resident preferences. Residents are supported to maintain links within the community.

Medication policies reflect legislative requirements and guidelines. The manager and health care assistants are responsible for administration of medications and have completed medication education and competencies. The medicine charts reviewed met prescribing requirements and is reviewed at least three-monthly by the general practitioner. Medications are stored securely.

All food and baking are prepared and cooked on site. Residents' food preferences, dietary and cultural requirements are identified on admission. A dietitian has reviewed the menu annually. The menu meets the required nutritional values.

Transfers and referrals are made in coordination with residents and families.

## Te aro ki te tangata me te taiao haumaru | Person-centred and safe environment


Includes 2 subsections that support an outcome where Health and disability services are provided in a safe environment appropriate to the age and needs of the people receiving services that facilitates independence and meets the needs of people with disabilities.



The building has a current warrant of fitness and an approved fire evacuation scheme. Fire drills occur six-monthly. There is a planned and reactive maintenance programme in place. Security arrangements are in place in the event of a fire or external disaster. Visitors and staff are clearly identifiable. There is a printed up-to-date resident list for evacuation purposes.

## Te kaupare pokenga me te kaitiakitanga patu huakita | Infection prevention and antimicrobial stewardship

Includes 5 subsections that support an outcome where Health and disability service providers' infection prevention (IP) and antimicrobial stewardship (AMS) strategies define a clear vision and purpose, with quality of care, welfare, and safety at the centre. The IP and AMS programmes are up to date and informed by evidence and are an expression of a strategy that seeks to maximise quality of care and minimise infection risk and adverse effects from antibiotic use, such as antimicrobial resistance.



Infection prevention management systems are in place to minimise the risk of infection to residents, service providers and visitors. The infection control programme is implemented and meets the needs of the organisation and provides information and resources to inform the service providers. Documentation evidenced that relevant infection control education is provided to all staff as part of their orientation and as part of the ongoing in-service education programme. Antimicrobial usage is monitored.

The type of surveillance undertaken is appropriate to the size and complexity of the organisation. Standardised definitions are used for the identification and classification of infection events. Results of surveillance are acted upon, evaluated, and reported to relevant personnel in a timely manner.

A pandemic plan and Covid-19 response plans and are in place and the service has access to personal protective equipment and supplies. There has been one Covid-19 exposure event in July 2022. This was appropriately reported and effectively managed.

Chemicals are stored securely in the facility. Staff receive training and education to ensure safe and appropriate handling of waste and hazardous substances. There are documented processes in place, and incidents are reported in a timely manner. Documented policies and procedures for the cleaning and laundry services are implemented with appropriate monitoring systems in place to evaluate the effectiveness of these services.

### Here taratahi | Restraint and seclusion

Includes 4 subsections that support outcomes where Services shall aim for a restraint and seclusion free environment, in which people's dignity and mana are maintained.



Palm Tree Rest Home strives to maintain a restraint-free environment. At the time of the audit, there were no residents using a restraint. Restraint minimisation training is included as part of the annual mandatory training plan and orientation.

Evidence is documented in the resident care plans and observed in practice. A comprehensive Māori assessment plan is ready when needed that informs the care plan. The care home has a key relationship with He Kāmaka Waiora Māori mental health service who provide Māori cultural support to the facility. The owners have a business partner who is a Māori elder who provides cultural support.  The aim of Palm Tree Rest Home is to build a workforce that can confidently and competently apply tikanga Māori to enable them to support tāngata whenua residents and their whānau; to incorporate

tikanga into daily practice; to ensure policies and procedures meet Ngā Paerewa Health and Disability Services Standard 2021; and to assist in health equity for all. The manager who is a registered nurse (RN), and who is one of the owners stated that they support increasing Māori capacity by employing more Māori applicants when they apply for employment opportunities as stated in their Māori health plan. At the time of the audit, there were no staff members who identify as Māori. Staff interviewed confirm they feel very supported by the managers and owners. Seven residents and two relatives interviewed confirm that individual cultural beliefs and values, knowledge, arts, and personality are respected. The manager described how the equitable employment process helped to increase the capacity and capability of the Pasifika workforce. Interviews with the manager and five staff (two health care assistants (HCA), one cook, one diversional therapist who is also an owner and one maintenance person who is an owner), and documentation reviewed identified that the service place residents and family at the heart of their services.

Subsection 1.3: My rights during service delivery  The People: My rights have meaningful effect through the actions and behaviours of others.  Te Tiriti:Service providers recognise Māori mana motuhake (self-determination). The manager discusses aspects of the Code with residents and their family on admission.

requirements.		Discussions relating to the Code are held during individual resident's discussion meetings that occurs with each resident at least once a week. Family/whānau can attend. Residents and relatives interviewed reported that the service is upholding the residents' rights. Interactions observed between staff and residents during the audit were respectful.
		Information about the Nationwide Health and Disability Advocacy Service is available at the entrance to the facility and in the entry pack of information provided to residents and their family/whānau. There are links to spiritual supports. Church services are available. The service recognises Māori mana motuhake and this is reflected in the Māori health plan.
		Staff receive education in relation to the Code at orientation and through the annual education and training programme, which includes (but not limited to) understanding the role of advocacy services. Advocacy services are linked to the complaints process.

		service promotes care that is holistic and collective in nature through educating staff about te ao Māori and listening to tāngata whaikaha when planning or changing services.
		It was observed that residents are treated with dignity and respect. Weekly resident /family feedback from resident's individual meetings documents resident's satisfaction with the service. Results confirmed that residents and families are treated with respect. This was also confirmed during interviews with residents and families.
		There are two rooms with a connected door which are occupied by a married couple. A sexuality and intimacy policy is in place with training as part of the education schedule. Staff interviewed stated they respect each resident's right to have space for intimate relationships.
		Staff were observed to use person-centred and respectful language with residents. Residents and families interviewed were positive about the service in relation to their values and beliefs being considered and met. Privacy is ensured and independence is encouraged. Gender and sexuality are respected.
		Residents' files and care plans identified residents preferred names. Values and beliefs information is gathered on admission with family involvement and is integrated into the residents' care plans. Spiritual needs are identified, church services are accessible and spiritual support is available. A spirituality policy is in place.
		Te reo Māori is celebrated, and staff are encouraged and supported with correct pronunciation. Te reo Māori resources are available for staff to access. Staff were observed talking to Chinese and Russian residents in their own languages.
		Cultural awareness training is provided annually and covers Te Tiriti o Waitangi and tikanga Māori.

Cultural diversity is acknowledged, and staff are educated on systemic racism and the understanding of injustices through policy and the house rules.  Staff complete education on orientation and annually as per the training plan on how to identify abuse and neglect. Staff are educated on how to value the older person, showing them respect and dignity. All residents and families interviewed confirmed that the staff are very caring, supportive, and respectful.  Police checks are completed as part of the employment process. The service implements a process to manage residents' comfort funds. Professional boundaries are defined in job descriptions. Interviews with the RN and caregiver confirmed their understanding of professional boundaries, including the boundaries of their role and responsibilities. Professional boundaries are covered as part of orientation.  Residents have enduring power of attorney for finance and wellbeing documented in their files (viewed). Residents have property documented and signed for on entry to the service. Residents and family have information on resident's possessions and accountability management of those, within the resident's signed service level agreement  Te Whare Tapa Whā is recognised and implemented in the workplace as part of all staff wellbeing, with the aim to improve outcomes for Māori staff and Māori residents. This aligns with the Māori health plan.

Residents are asked for their consent before adverse event data is passed to family/enduring power of attorney (EPOA). An interpreter policy and contact details of interpreters is available. Interpreter services are used where indicated. At the time of the audit, there were residents who speak Mandarin and Russian and did not speak or fully understand English; however, staff and management could speak Mandarin and a staff member can speak Russian. The staff also have picture cards to communicate with residents who find spoken English difficult.  The residents and family are informed prior to entry of the scope of services and any items that are not covered by the agreement.  The service communicates with other agencies that are involved with the resident, such as the hospice and Te Whatu Ora – Waitemata specialist services. The delivery of care involves a multidisciplinary team approach. Residents or the enduring power of attorney (EPOA) provide consent in regard to services involved. The manager described an implemented process around providing residents with time for discussion around care, time to consider decisions, and opportunity for further discussion, if required.  Residents and relatives interviewed confirm they know what is happening within the facility and felt informed regarding events/changes through emails, phone calls and resident catchups.

Discussions with residents and relatives confirmed they are provided with information on complaints and complaints forms are available at the entrance to the facility and can be handed in. Residents have a variety of avenues they can choose from to make a complaint or express a concern. Resident individual meetings are held at least weekly where concerns can be raised. During interviews with relatives, they confirmed the manager is available to listen to

concerns and act promptly should issues arise. Residents and families making a complaint can involve an independent support person in the process if they choose. Information about the support resources for Māori is available to assist Māori residents in the complaints process. The owner acknowledged the understanding that for Māori there is a preference for face-to-face communication. The owners have business partners who own four Auckland aged care facilities. One of the business partners is a Māori elder and advises the owners on cultural requirements. The owners meet at least weekly to discuss any management or clinical changes. A monthly reporting process from quality and risk data is collated for monitoring incidents, adverse events, restraint use (if any), infections, and care plan timeframes. Palm Tree Rest Home has an annual business, quality and risk management plan 2023. This contains identified objectives for their mission, services, and values which link to their strategic direction, and goals are regularly reviewed with outcomes documented. The business plan reflects a commitment to collaborate with Māori, aligns with the Ministry of Health strategies and addresses barriers to equitable service delivery. The working practices at Palm Tree Rest Home are holistic in nature, inclusive of cultural identity, and respect connection to family, whānau and the wider community as an intrinsic aspect of wellbeing and improved health outcomes for tangata whaikaha. The diversional therapist who is also an owner supports

residents to maintain links with the community. Satisfaction surveys and resident individual weekly catch up provides opportunities for residents, relatives/whānau and tāngata whaikaha to provide feedback around all aspects of the service to improve health outcomes. The annual quality and risk management programme reflects evidence of regular compliance and risk reporting that highlight operational goals. Outcomes and corrective actions are shared and discussed in all staff meetings. The owners have owned the facility since July 2022. The owner is the manager and is a registered nurse who has five years' experience in aged care management. They have maintained at least eight hours of professional development activities related to their role. Subsection 2.2: Quality and risk FΑ There is a documented business, quality and risk management plan. Facility meetings provide an avenue for discussions in relation to (but not limited to): quality data; health and safety; infection control/pandemic strategies; complaints received (if any); cultural compliance; staffing; and education. Internal audits, meetings, and the collation of data take place as scheduled. Corrective actions are documented where indicated to address service improvements, with evidence of progress and sign off by the manager when achieved. Meeting minutes and quality results data are provided to staff. Corrective actions are discussed in staff meetings to ensure any outstanding matters are addressed with sign-off when completed.

Information and feedback from the resident and family satisfaction survey are collated. Feedback indicates that both residents and family have high levels of satisfaction with the services being provided. Results have been communicated to residents and staff. Corrective actions are implemented to improve on any specific comments.

There are procedures to guide staff in managing clinical and nonclinical emergencies. Policies and procedures and associated implementation systems provide a good level of assurance that the facility is meeting accepted good practice and adhering to relevant standards. A document control system is in place. Policies are regularly reviewed and have been updated to meet the Ngā Paerewa Health and Disability Services Standard 2021.

A health and safety system is in place. The health and safety representative is the manager who has attended health and safety training. Health and safety notices are posted on a noticeboard. Hazard identification forms and an up-to-date hazard register were sighted. Each hazard is risk rated with controls put into place. Hazards are regularly monitored. Staff incidents, hazards and risk information is reported to the other two owners by the manager. Health and safety is a regular agenda item in staff two monthly meetings. Group text messages are also used to immediately inform staff of hazards newly identified.

Reports are completed for each incident/accident. Immediate actions are documented with any follow-up action(s) required, evidenced in the accident/incident forms reviewed. Incident and accident data is collated monthly and analysed. A summary is provided against each clinical indicator. Each event involving a resident, triggers a clinical assessment and the timely follow up by the manager. Family are notified following incidents unless the resident requests that they not be informed.

Discussions with the manager evidenced their awareness of the requirement to notify relevant authorities in relation to essential notifications. There have been no Section 31 notifications in 2022 or 2023. There was one Covid 19 exposure outbreaks in July 2022. This was appropriately notified.

Staff have completed cultural training to ensure a cultural safe service is provided for Māori. Review of policies provide a critical analysis of practice to improve health equity. They provide on-call cover. Every shift has a health care assistant (HCA) with a current first aid certificate and is medication competent. HCAs undertake laundry and cleaning duties. There is an annual education and training schedule being implemented, both inhouse and online. The education and training schedule lists compulsory training. Caregivers and the RN receive training as per the training schedule. Staff complete training as part of their orientation and ongoing. Topics include (but are not limited to): infection control; cultural awareness; chemical safety; emergency management, including (six-monthly) fire drills; personal protective equipment training; and hazard reporting. External training can be accessed through the mental health team and the geriatrician nurse specialist from Te Whatu Ora - Waitematā. Staff participate in learning opportunities that provide them with up-to-date information on Māori health outcomes and disparities, and health equity. The manager and caregivers complete annual cultural training. Staff confirmed that they were provided with resources during their cultural training to learn about te Tiriti o Waitangi, the meaning of mana

motuhake and addressing inequities. The manager (RN) and senior healthcare assistants complete medication and controlled drug administration competencies. There are currently no residents requiring controlled drugs in the facility. The manager has completed interRAI training. If agency staff are used, their orientation covers health and safety and emergency procedures (clinical and non-clinical). Staff wellness is encouraged through participation in health and wellbeing activities. Staff are supported through the annual appraisal and debriefing. Subsection 2.5: Information  The people: Service providers manage my information sensitively and in accordance with my wishes.  Te Tiriti: Service providers collect, store, and use quality ethnicity data in order to achieve Māori health equity.  As service provider: We ensure the collection, storage, and use of personal and health information of people using our services is accurate, sufficient, secure, accessible, and confidential. The resident files are appropriate to the service type and demonstrate service integration. Records are uniquely identifiable, legible, and timely. Any signatures that are documented, include the name and designation of the service provider.  Residents entering the service have all relevant initial information recorded within 24 hours of entry into the resident's individual record. An initial care plan is also developed in this time. Personal resident information is kept confidential and cannot be viewed by other residents or members of the public. The service is not responsible for National Health Index registration.
Subsection 3.1: Entry and declining entry  The people: Service providers clearly communicate access, timeframes, and costs of accessing services, so that I can choose the most appropriate service provider to meet my needs.  Te Tiriti: Service providers work proactively to eliminate inequities between Māori and non-Māori by ensuring fair access to quality care.  As service providers: When people enter our service, we adopt a person-centred and whānau-centred approach to their care. We focus on their needs and goals and encourage input from whānau. Where we are unable to meet these needs, adequate information about the reasons for this decision is documented and communicated to the person and whānau.	FA	There is an information folder available for all prospective residents and family. The admission policy/decline to entry policy and procedure guides staff around admission and declining processes, including required documentation. This details all admission and declining entry information. Prospective residents and their family are kept informed of any decisions. On the occasions where entry is declined reasons are provided, and the prospective resident and family are referred to the referrer. All residents entering the service have been assessed by the needs assessment service coordination service. The manager keeps paper records of how many prospective residents and families have viewed the facility, admissions and declined referrals. The document includes ethnicity details. Support is available for residents through Te Whatu Ora - Waitematā specialist services.

#### Subsection 3.2: My pathway to wellbeing

The people: I work together with my service providers so they know what matters to me, and we can decide what best supports my wellbeing.

Te Tiriti: Service providers work in partnership with Māori and whānau, and support their aspirations, mana motuhake, and whānau rangatiratanga.

As service providers: We work in partnership with people and whānau to support wellbeing.

#### FΑ

Date of Audit: 15 May 2023

Five rest home resident clinical files were reviewed including one resident under a mental health contract. The manager completes an initial assessment and care plan on admission, including relevant risk assessment tools. Initial care plans for long-term residents reviewed were evaluated by the manager within three weeks of admission. Risk assessments are completed six-monthly or earlier if indicated due to health changes.

InterRAI assessments and long-term care plans were completed within the required timeframes, with outcomes of assessments reflected in the needs and supports documented in the resident care plans. The interRAI assessment links effectively to the long-term care plan. Interventions recorded in the long-term care plan to address medical and non-medical needs were comprehensive to a level of detail that sufficiently guide staff in the care of the resident.

The care plans reviewed were resident focused and individualised. Long-term care plans identified all support needs, goals, and interventions to manage medical needs/risks. Care plans include allied health and external service provider involvement. Short-term needs such as current infections, wounds, weight loss, or recent falls are documented and signed off when resolved. The resident funded under a mental health contract had an initial assessment, and a long-term care plan in place.

Care plans had been evaluated at least six-monthly for long-term residents who had been in the service six months. Residents and whānau interviewed confirmed that they participate in the care planning process and review. The GP has reviewed residents three-monthly. The manager interviewed described working in partnership with the resident and whānau to develop initial and long-term care plans.

The manager interviewed had a good knowledge of care being delivered based on the four cornerstones of Māori health 'Te Whare Tapa Whā'

The service contracts with a medical centre whose general practitioner (GP) provides medical services to residents. The GP visits monthly and as required. New admissions and residents needing more frequent review are seen by the GP. The GP takes

after-hours calls for advice, and residents with serious health concerns are transferred to the public hospital. The GP (interviewed) stated he is notified in a timely manner for any residents with health concerns and was complimentary of the standard of care provided by the facility. A physiotherapist and podiatrist are contacted as required.

Residents interviewed reported their needs were being met. Family members interviewed stated their relative's needs were being appropriately met and stated they are notified of all changes to health, as evidenced in residents' progress notes.

There is currently one wound / leg laceration and no pressure injuries. Wound management policies and procedures were in place. Adequate dressing supplies were sighted in treatment cupboards.

Caregivers interviewed stated there are adequate clinical supplies and equipment provided including continence, wound care supplies and pressure injury prevention resources. A continence specialist can be accessed as required.

Monitoring charts included (but not limited to): weights; neurological observations; vital signs; turning schedules; and fluid balance recordings. Monitoring charts were implemented according to the care plan interventions. Incident reports reviewed evidenced timely follow up and investigation by the manager/RN. Any opportunities identified to minimise future risks were identified and implemented.

The manager reported they routinely invite whānau to the six-monthly review meetings along with the resident. Communication with relatives was evidenced in resident's files and on interview with family. There is currently one Māori residents and documentation demonstrated care planning to maintain independence and meeting their chosen outcomes. The service supports the resident and whānau to identify their own pae ora outcomes in their care or support plan. Health care assistants interviewed advised that a verbal handover occurs on each shift. Progress notes are maintained by the health care assistants and the manager weekly or if there are any incidents or changes in residents' health status.

Subsection 3.3: Individualised activities  The people: I participate in what matters to me in a way that I like.  Te Tiriti: Service providers support Māori community initiatives and activities that promote whanaungatanga.  As service providers: We support the people using our services to maintain and develop their interests and participate in meaningful community and social activities, planned and unplanned, which are suitable for their age and stage and are satisfying to them.	FA	There is one part time diversional therapist who is an owner and one part time activities assistant who works 10 hours a week. Health care assistants participate in the activities programme. The weekly activities programme is displayed on a whiteboard in the lounge.  The manager completes a social/leisure assessment on admission
		for all residents which informs the activity plan for each resident. The activity plan is reviewed at least six-monthly or earlier as required. Activity attendance records are maintained. The planner has one-on-one activities such as walks, hand and nail therapy, reading, and sensory activities. On the day of audit residents were observed exercising, going for walks, listening to music, and watching TV.
		Church services are available, and residents are supported to attend their own church. Minibus outings take place to local shops and beaches. There are visiting local groups including school visits to the facility and entertainers. The activities assistant takes residents out for walks to the local shops and beach. They drive residents unable to mobilise well, in the facility car. There are celebrations such as Christmas, Easter, Anzac Day, Matariki and Chinese New Year. Te ao Māori signage and access to learning is available to residents and staff. Local marae contacts are available, and one of the business partners of the owners is a Māori elder and is available for advice when required.
Subsection 3.4: My medication  The people: I receive my medication and blood products in a safe and timely manner.  Te Tiriti: Service providers shall support and advocate for Māori to access appropriate medication and blood products.	FA	Policies and procedures are in place for safe medicine management. Medications are stored safely in a locked cupboard. The manager and medication competent health care assistants administer medications. All robotic roll packs are checked on delivery against the electronic medication charts.
As service providers: We ensure people receive their medication and blood products in a safe and timely manner that complies with current legislative requirements and safe practice guidelines.		Policies and procedures for residents self-administering medications are in place and this includes ensuring residents are competent, and the safe storage of medications. There were no resident self-administering medications on the day of the audit.
		All medication errors are reported and collated with quality data.  Medication internal audits are completed six-monthly.

The medication fridge and cupboard temperatures are recorded and maintained within the acceptable temperature range. All eye drops sighted in the medication trollevs were dated on opening. All medications no longer required are returned to pharmacy. There were no expired drugs on site on the day of the audit. There are no standing orders and the manager advised that the GP prescribes over-the-counter medications. Ten electronic medication charts were reviewed and met prescribing requirements. Medication charts had photo identification and allergy status notified. The GP had reviewed the medication charts threemonthly for those residents that had been at the facility for longer than three months. 'As required' medications had prescribed indications for use and were administered appropriately with outcomes documented in progress notes. One medication competent health care assistant was observed administrating medications correctly on the day of audit. Residents and relatives interviewed stated they are updated around medication changes, including the reason for changing medications and side effects. The manager /RN and healthcare assistant described working in partnership with all residents and whānau to ensure that appropriate support is in place, advice is timely, and treatment is prioritised to achieve better health outcomes. Subsection 3.5: Nutrition to support wellbeing FΑ The cook has received food safety training. Health care assistants assist with meal service and have received food handling training. The people: Service providers meet my nutritional needs and The cook consults directly with residents to gain feedback of the food consider my food preferences. services and adjusts the menu if there are any special requests. Te Tiriti: Menu development respects and supports cultural beliefs, When interviewed, the cook stated that they could cater for different values, and protocols around food and access to traditional foods. cultures (including Māori, Pasifika and Chinese) when required. The As service providers: We ensure people's nutrition and hydration menu was reviewed by a dietitian on 5 May 2023. needs are met to promote and maintain their health and wellbeing. There is a current food control plan which expires on 31 August 2023 and Council A certificate dated 10th July 2023. The cook advised they receive resident dietary profiles and are notified of any dietary changes for residents from the manager. The residents have a nutritional profile developed on admission, which

		identifies cultural and dietary requirements, likes, and dislikes. The cook is also notified of any resident's weight loss and can provide extra protein or supplementary drinks as prescribed. Review by a dietitian is requested if required.  Food temperatures, fridge and freezer temperatures are recorded electronically and are all within safe limits. Food is served directly from the kitchen to the dining room, there is a pleasant ambience in the dining room.
Subsection 3.6: Transition, transfer, and discharge  The people: I work together with my service provider so they know what matters to me, and we can decide what best supports my wellbeing when I leave the service.  Te Tiriti: Service providers advocate for Māori to ensure they and whānau receive the necessary support during their transition, transfer, and discharge.  As service providers: We ensure the people using our service experience consistency and continuity when leaving our services. We work alongside each person and whānau to provide and coordinate a supported transition of care or support.	FA	The transfer and discharge of resident management policy ensures a smooth, safe, and well organised transfer or discharge of residents. The manager interviewed described how exits, discharges or transfers are coordinated in collaboration with the resident and whānau to ensure continuity of care. There was evidence that residents and their families were involved for all exits or discharges to and from the service and can ask questions. The service utilises the 'yellow envelope' transfer documentation system. A copy of the advance directives, medication chart and a transfer report are included in the yellow envelope. A verbal handover is provided. The manager updates health care assistants on new admissions regarding care and support requirements during handover. Referral to other health and disability services is evident in the resident files reviewed.
Subsection 4.1: The facility  The people: I feel the environment is designed in a way that is safe and is sensitive to my needs. I am able to enter, exit, and move around the environment freely and safely.  Te Tiriti: The environment and setting are designed to be Māoricentred and culturally safe for Māori and whānau.  As service providers: Our physical environment is safe, well maintained, tidy, and comfortable and accessible, and the people we deliver services to can move independently and freely throughout. The physical environment optimises people's sense of	FA	The facility is on one level. There are twenty-eight rest home rooms. Six rooms have adjoining lockable doors that can be utilised as adjoining rooms if required or can be kept locked. On the day of the audit, one married couple were using this arrangement and had unlocked adjoining doors. All rooms share communal toilets and showers. There are adequate numbers of accessible bathrooms and toilets throughout the facility. Appropriately secured and approved handrails are provided in the toilet/shower areas and other equipment/accessories are available to promote residents' independence.

belonging, independence, interaction, and function.		Adequate personal space is provided to allow residents and staff to move around within their bedrooms safely. Rooms are personalised with furnishings, photos and other personal items displayed. There is a spacious lounge and a dining room adjacent to the kitchen. There are external areas with shade, accessible to the residents and there is safe access to a spacious garden. The environment is inclusive of peoples' cultures and supports cultural practices.  The maintenance management policy ensures the interior and exterior of the facility are maintained to a good standard, and all equipment is maintained, serviced and safe. The building has a current warrant of fitness which expires on 21 August 2023. The service has a part-time maintenance and garden person who is also an owner. There are essential contractors who can be contacted 24/7 every day as required. Maintenance requests are completed on the paper management system and checked off once competed by the maintenance person.  There is a preventative maintenance schedule which is maintained. The planned maintenance schedule includes electrical equipment testing and tagging, equipment checks, calibrations of weigh scales and clinical equipment and testing, which are all current. Weekly hot water temperature checks are completed regularly throughout the facility and are within expected ranges. There is electric heating (radiators) and heat pump unit.  There is a plan in place to redecorate rooms and they are progressing through this. Although there are no current plans to expand the building, the manager is aware of their obligation to ensure designs and environments reflect the aspirations and identity of Māori, for any new additions or new building construction that may arise in the future.

As service providers: We deliver care and support in a planned and safe way, including during an emergency or unexpected event.		case of an emergency. Emergency management is included in staff orientation and ongoing as part of the education plan. There is always a person on duty with a first aid certificate.  A fire evacuation plan is in place that has been approved by the New Zealand Fire Service. Fire evacuation drills are held six-monthly, and last occurred in December 2022. There are emergency management plans in place to ensure health, civil defence and other emergencies are included. The service has adequate resources, including food and water to last for at least two weeks. There is a gas cooker with bottle. All supplies are checked six-monthly.  There are call bells in the residents' rooms and ensuites, communal toilets and lounge/dining room areas. Residents were observed to have their call bells in close proximity. Residents and families interviewed confirmed that call bells are answered in a timely manner.  An emergency generator can be obtained if required.  Security cameras monitor the building The building is secure after hours and staff complete security checks at night. There is external security lighting.
Subsection 5.1: Governance  The people: I trust the service provider shows competent leadership to manage my risk of infection and use antimicrobials appropriately. Te Tiriti: Monitoring of equity for Māori is an important component of IP and AMS programme governance.  As service providers: Our governance is accountable for ensuring the IP and AMS needs of our service are being met, and we participate in national and regional IP and AMS programmes and respond to relevant issues of national and regional concern.	FA	The manager undertakes the role of infection control coordinator to oversee infection control and prevention across the service. The job description outlines the responsibility of the role. The infection prevention and control programme, its content and detail, is appropriate for the size, complexity and degree of risk associated with the service. Infection control is linked into the quality risk and incident reporting system. The infection control programme is reviewed annually, and any significant issues are escalated through an effective communication pathway to the owner. Documentation review evidenced a Covid-19 outbreak in July 2022, which was immediately escalated to the owner. There is an infection control committee that meets monthly. Infection rates are presented and discussed at staff meetings and collated in a report by the owner and discussed with the other two owners. Infection prevention and control

are part of the strategic, business and quality plans. The service has access to an infection prevention clinical nurse specialist from Te Whatu Ora - Waitematā if required. There are policies and procedures in place to manage significant infection control events. Any significant events are managed using a collaborative approach and involve the manager, the GP, and the Public Health team. Visitors are asked not to visit if unwell. There are hand sanitisers strategically placed around the facility. Residents and staff are offered influenza and Covid vaccinations. The infection control coordinator has input into the procurement of personal protective equipment (PPE), medical and wound care products. Consumables are checked for expiry dates. The owner reported there were no plans for major refurbishment or building projects; however, if the opportunity arises, the manager will have input to planning. The infection control manual outlines a comprehensive range of policies, standards and guidelines and includes defining roles, responsibilities and oversight, the infection control committee and

training and education of staff. Policies and procedures are reviewed annually and are available to staff. Aseptic techniques are promoted through handwashing, sterile single use packs for wound cares and creating an environment to prevent contamination from pathogens. There are adequate accessible handwashing facilities with flowing soap, paper towels and hand sanitisers. The facility has support from Māori advisors for the protection of culturally safe practice and have available all policies and educational resources in te reo Māori and acknowledge the spirit of Te Tiriti. Infection control practices include laundry and cleaning practices that reflect and promote culturally safe practice. There are policies and procedures in place around reusable and single use equipment. All shared equipment is appropriately disinfected between use. Reusable medical equipment is cleaned and disinfected after use and prior to next use. The service includes the checking of these processes in the cleaning, environmental and maintenance of equipment audits. All staff received training in cleaning protocols and procedures related to the cleaning of reusable medical equipment and high touch areas. The infection control policy states that the facility is committed to the ongoing education of staff and residents. Infection prevention and control is part of staff orientation and included in the annual training plan. There has been additional training and education around Covid-19. Staff have completed handwashing and personal protective equipment training. Resident education occurs as part of the daily cares and individual welfare meetings. Residents and families/ whānau were kept informed and updated on Covid-19 policies and procedures through phone calls, and emails. The infection control coordinator uses the information obtained through surveillance to determine infection prevention and control activities, resources, and education needs within the facility. There is close liaison with the GPs that advise and provide feedback/information to the service. Systems in place are appropriate to the size and complexity of the service. Action plans are required for any infection rates of concern. Internal infection control audits are completed with corrective actions for areas of improvement. The service receives email notifications and alerts from Te Whatu Ora -Waitematā for any community concerns. Ethnicity data is collected on the electronic surveillance form submissions and analysed by the manager. The data is then used to inform future strategic planning and service delivery. There has been one Covid exposure event in July 2022. The outbreak was documented with evidence of comprehensive management, regular outbreak meetings and debrief meetings. The infection control coordinator interviewed described the daily update and debrief meeting that occurred. The service completed a 'lessons

		learned' after the event to prevent, prepare for and respond to future infectious disease outbreaks. The infection control coordinator confirmed that the screening process, cohorting of residents and care delivery within a constrained workforce proved to be successful. Staff confirmed that during the Covid exposure period resources including PPE were adequate. Residents and families/ whānau were updated throughout the event.
Subsection 5.5: Environment  The people: I trust health care and support workers to maintain a hygienic environment. My feedback is sought on cleanliness within the environment.  Te Tiriti: Māori are assured that culturally safe and appropriate decisions are made in relation to infection prevention and environment. Communication about the environment is culturally safe and easily accessible.  As service providers: We deliver services in a clean, hygienic environment that facilitates the prevention of infection and transmission of antimicrobialresistant organisms.	FA	The facility implements a waste and hazardous management policy that conforms to legislative and local council requirements. Policies include (but are not limited to) incident/accident and hazards reporting; use of PPE; and disposal of general, infectious, and hazardous waste.  Current material safety data information sheets are available and accessible to staff in relevant places in the facility, the sluice room, laundry, and cleaning storerooms. Staff receive training and education in waste management and infection control as a component of the mandatory training.  Interviews and observations confirmed that there is plenty PPE and equipment provided, such as aprons, gloves, and masks. Interviews confirmed that the use of PPE is appropriate to the recognised risks. Observation confirmed that PPE was used in high-risk areas.  Cleaning services are provided seven days a week. The sluice room has aprons, goggles, and gloves available. Cleaning duties and procedures are documented to ensure correct cleaning processes occur. Cleaning products are dispensed according to the cleaning procedure. There is a designated locked storeroom for the safe and hygienic storage of cleaning equipment and chemicals. HCAs work in the laundry and as cleaners and are aware of the requirement to keep their cleaning trolleys in sight. Chemical bottles in storage and in use were noted to be appropriately labelled. Chemicals are stored securely, and a spill kit is available.  The safe and hygienic collection and transport of laundry items was witnessed. All laundry inclusive of resident's clothing is laundered on site. Visual inspection of the on-site laundry, demonstrated the

		implementation of a clean/dirty process for the hygienic washing, drying, and handling of these items. Residents' clothing is labelled and personally delivered from the laundry to their rooms. The effectiveness of the cleaning and laundry processes are monitored through the internal audit system with oversight from the infection control coordinator. Residents and families/ whānau confirmed satisfaction with housekeeping and laundry services during interviews, and in satisfaction surveys.
Subsection 6.1: A process of restraint  The people: I trust the service provider is committed to improving policies, systems, and processes to ensure I am free from restrictions.  Te Tiriti: Service providers work in partnership with Māori to ensure services are mana enhancing and use least restrictive practices. As service providers: We demonstrate the rationale for the use of restraint in the context of aiming for elimination.	FA	The restraint approval process is described in the restraint policy and procedures meet the requirements of the restraint minimisation and safe practice standards and provide guidance on the safe use of restraints. The manger is the restraint coordinator and provides support and oversight for restraint management in the facility.  An interview with the restraint coordinator described the facilities commitment to restraint elimination and has not used any restraints since they purchased the facility last year. They are conversant with restraint policies and procedures. The facility has no residents on restraint at the time of the audit. Restraint minimisation training for staff, begins during their orientation, and continues annually.  The reporting process includes data gathered and analysed monthly that supports the ongoing safety of residents and staff. If used, a review of the records for residents requiring restraint would cover the restraint assessment, consent, monitoring, and evaluation. Family/whānau approval would be sought should any resident be unable to consent to the use of restraint. Any impact on family/whānau would also be considered.
