- **2.** Commencement—This notice comes into force on 1 October 2012.
- **3. Amendment** The principal notice is amended by revoking Schedule 1 and substituting the new Schedule 1 set out in the Schedule to this Notice.
- 4. Transitional provision relating to implementation of amendment—
- (1) The default transitional provisions in clause A12 of the principal notice apply to this amendment.
- (2) For the purposes of applying the default transitional provisions, the implementation date for this amendment is 1 October 2012
