# **Primary Maternity Services Amendment Notice 2020**

### Notice

## 1. Title—

(1) This notice is the Primary Maternity Services Amendment Notice 2020.

(2) In this notice, the Primary Maternity Services Notice 2007, which was published as a Supplement to the New Zealand Gazette, 13 April 2007, No. 41, page 1025, and became effective from 1 July 2007, is called the **principal notice**.

2. Commencement— This notice comes into force on 1 July 2020.

**3. Amendment to Schedule 1**— The principal notice is amended by revoking Schedule 1 and substituting the new Schedule 1 set out in the Schedule to this notice.

### **4. Revocation**— The following notice is revoked:

a. The Primary Maternity Services Amendment Notice 2019, which was published in the *New Zealand Gazette*, 27 June 2019, Notice Number **2019-go2897** and became effective from 1 July 2019.
