Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) on 1 December 2020 for information regarding vaccines.

Information in response to each part of your request is outlined below.

Could you please tell me what vaccine manufacturers has the NZ government invested money in?

The Government doesn't invest in vaccine manufacturers, it buys vaccines (and other pharmaceuticals) from manufacturers. Generally, PHARMAC negotiates with manufacturers to buy vaccines on the National Immunisation Schedule, although the Ministry of Business, Innovation and Employment (MBIE) is undertaking this role with respect to COVID-19 vaccines in development.

Are such manufacturers immune to liability in case negative side effects occur later down line?

In case of vaccine related injuries, who will be held accountable please and who will cover the health related cost?

In New Zealand, all injuries, including vaccine-related injuries, are covered by the Accident Compensation Corporation. There is more information about the Corporation's work at: www.acc.co.nz/about-us/who-we-are/what-we-do/#help-when-youre-injured-in-an-accident.

Other rules are in place to ensure that vaccines and other medicines are safe and effective – this includes Medsafe's work as the authority responsible for the regulation of therapeutic products in New Zealand. Medsafe decides whether a product such as a vaccine is safe and effective enough to be approved for use in New Zealand and can prosecute manufacturers if they are in breach of the Medicines Act 1981.
