## Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) on 2021 for:

"A breakdown of the numbers of people vaccinated against Covid-19 per group (1, 2, 3, 4) to date, preferably by DHB.

If possible broken down into the sub groups (1a, 1b, 2a, 2b, 2c, 3a, 3b, 3c, 4)."

Please find attached an excel spreadsheet detailing the information you have requested. Please note the following caveats regarding the data provided:

- Data is current up to 11:59pm on 14 June 2021 and was extracted on 15 June 2021 and • reflects doses administered and entered into the COVID-19 Immunisation Register (CIR).
- Group 1a: Border Workers includes port, airport staff and Managed Isolation Quarantine • (MIQ) workforces covered by the current Required Testing Order (2020). In addition, it includes individuals who have self-identified as border workers at the time of vaccination (except New Zealand Defence Force (NZDF) staff).
- Group 1b: Household contacts includes any person who usually resides in a household or similar setting with a border/MIQ worker - whether they are related to that person or not.
- Group 2a: Frontline health workers and emergency response services.
- Group 2b: Residential facility worker or resident, unknown, other, early vaccine access. Individuals vaccinated at NZDF sites who identify as border workers or household contacts.

Individuals over 65 and with underlying health conditions in the Counties Manukau District Health Board area.

- Group 3 New Zealand public who are over 65 or at an elevated risk of severe illness from COVID-19.
- Group 4 The general population aged 16 and over. Several sites are vaccinating individuals from group 4 to minimise wastage and to vaccinate whanau who attend with group 3 individuals.

There also may be several instances of vaccinators entering group 4 into the system in error as the case reason when the person is actually eligible under group 3.
