Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health (the Ministry) on 10 May 2021 regarding COVID-19 vaccines. A copy of your full request is enclosed for reference.

Medsafe cannot produce all the contents of the vaccine here in New Zealand. The effects and risk management of the vaccine is also publicly available at:

Turning to the remainder of your request (parts five to 38), it appears you are asking the Ministry to prove the safety and efficacy of the COVID-19 vaccine. While the Act enables people to request official information from the Ministry, it only applies to information it holds. There is no obligation to create information or compile information it does not hold in order to respond to requests, nor is the Ministry obliged to provide an opinion.

Therefore, I am refusing these parts of your request under section 18(g)(i) of the Act, as the information requested is not held by the Ministry and there are no grounds for believing it is held by another agency subject to the Act.
