## Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) on 12 November 2021 for information relating to the Intensive Care Units (ICU) and COVID-19. You requested the following:

"a detailed financial breakdown of all money directly spent on increasing ICU staffing and capacity across all DHB's in New Zealand in preparation for responding to the Covid-19 pandemic, and showing the details of all resources that have been affected"

\$2m was allocated from COVID-19 workforce funding to support district health boards (DHBs) to provide ICU surge training. All DHBs had funding approved for specific proposals. The funding is for 12 months from date of approval, which range from March 2021 through to September 2021. This funding covers nurse educator time, backfill, travel, and accommodation costs to access training. Some proposals covered all ICU-related staff, while others just covered nurses.

A breakdown of this funding can be found attached to this letter as "Financial breakdown by DHB". Please note, only \$1,626,766.02 has been allocated so far, as two proposals are pending. DHBs submit invoices and post-training claim forms on the completion of training, which is ongoing, therefore not all the available funding has been 'spent'.
