Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) received by the Ministry of Health (the Ministry) on 20 December 2021 for:

"A breakdown of the services funded by the National Services Framework and the budget spent on each? Is it also possible to share the total budget and spend per year for the last 2 financial years"

District health boards (DHBs) are bulk funded to ensure the provision of healthcare services to their resident populations. The majority of each DHBs devolved funding is allocated using the Population Based Funding Formula (PBFF). However, there are certain services which are very specialised and only provided by certain DHBs and the funding for these is not a good fit for allocations using the PBFF. Some National Services are a good example of these and are therefore funded as a discrete allocation within the relevant DHBs devolved funding. The Ministry is providing you with the details the funding allocated for these National Services over the last two years, attached as Appendix 1 to this letter. Please note, the Ministry only holds funding amounts which does not reflect actual expenditure figures.
