Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health (the Ministry) on 25 February 2022 for:

"Temporary significant service disruption exemptions for Vaccine Mandate. Please provide a summary list of all the DHB staff that were provided with the above, which DHB area, what dept and role they are in, and the reasoning for the exemption. Gender and age would also be useful, thank you."

On 25 March 2022, under section 15A of the Act, the Ministry extended the timeline to respond to your request until 19 April 2022 as further consultation was required.

Your request is for a significant amount of personal health information about district health board (DHB) workers. Rather than decline the request, the Ministry is providing the attached table which shows the number of DHB employees covered by the DHB's significant service disruption (SSD) exemption, granted by the Hon. Chris Hipkins, Minister for COVID-19 Response.

Some detail in the attached table is marked as '<5' to protect individual privacy and security of health information. Further, gender and age information are not required as a part of the exemption application, as such is not included in this reply. The table reports on data as 25 February 2022

Of the 1,446 granted for temporary SSD exemptions:

- 654 were for 6 weeks from 22 February
- 792 for ten days from 23 February

All the exemptions were granted because they were assessed as necessary to prevent significant service disruption at the DHB, as a critical health and disability service provider.
