Response to your request for official information

Thank you for your follow up request under the Official Information Act 1982 (the Act) to the Ministry of Health (the Ministry) on 1 March 2022. Please find a response to each part of your request below.

Since you've provided data for the latest financial year, can you please tell me the total number of clients seen by MHAS for the financial year 2020-21, including both DHBs and NGOs. (In 2019-20 the corresponding figure was 184,711.)

The total number of clients seen by Mental Health and Addiction Services between July 2020 and June 2021 is 191,293.

Please note the following caveats when interpreting the data:

- The information was sourced from the Programme for the Integration of Mental Health Data (PRIMHD) and extracted on 23 March 2021. PRIMHD is the Ministry's single national mental health and addiction (MHA) information collection of service activity and outcomes data for health consumers.
- 2. This information counts distinct clients seen by specialist MHA services in the 12-month period.
- 3. All age groups are included in this figure.
- 4. The figure includes both district health board (DHB) and non-governmental organisation (NGO) secondary MHA services.
- 5. Some organisations have breaks in reporting and/or incomplete data in PRIMHD for some time periods.
