Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act), which was transferred from The Treasury to the Ministry of Health (the Ministry) on 5 April 2022 for:

"Would you please provide by way of a schedule, for the years ended 30 June 2000 to 30 June 2021 inclusive, the total funds under the following headings: Crown Revenue

The total amount actually received each year as Crown Revenue with respect to the capital charges paid by District Health Boards (I do not require this information by DHB);

The total amount actually received as Crown Revenue from Specified Health Payments, otherwise known as the capital charge in the early years of the century. Appropriations

The total appropriations actually paid (not the Budget appropriation) to DHBs (I do not require this information by DHB) for:

- 1. Deficit support;
- 2. Equity support for deficits (the terminology in Vote Health differs from year to year);
- 3. Structural deficit support, and what is meant by "structural support;"
- 4. The total actually paid to DHBs to fund the capital charge.

I have endeavoured to extract the above data from each year's Vote Health but the format of the Vote Health documents in each budget is not consistent from year to year. For example, up to 2007 Crown Revenue reported the amounts paid by DHBs to the Crown for the capital charge but that information was not provided in subsequent Vote Health documents, hence my request. I have not been able to find this information anywhere else."

Document 1 attached to this letter contains the amounts paid by district health boards (DHBs) to the Crown for capital charge and the amounts paid as deficit support for the period from 1 July 2002 to 30 June 2021.

The information you requested regarding the approved funding specifically associated for capital charge is not available. Funding was devolved to the DHBs in the late 1990s and formed part of the total funding envelope from that point, and the total funding is provided to buy services that include input costs, including capital charge. Each year, adjustments are

made to increase or decrease funding depending upon the results of asset revaluations. There was a large exercise to remove debt from the DHBs in 2015 and 2016, with an associated increase in the capital charge paid and the funding provided. In recent years, there have also been adjustments made to the level of capital charge funding to compensate for Crown capital injections for major projects.
