## Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) on 2 June 2022 for information relating to Pfizer. You specifically requested:

""Pre purchase agreement between NZ Labour Govt. Cabinet and Pfizer drug company."

The contracts between Pfizer and the New Zealand Government are withheld in full under section 9(2)(b)(ii) of the Act where their release would likely unreasonably prejudice the commercial position of the person who supplied the information. I have considered the countervailing public interest in release in making this decision and consider that it does not outweigh the need to withhold at this time.

However, under section 13, the Ministry is providing the attached Appendix 1 which contains the dates of each agreement executed. All agreements between Pfizer and the New Zealand Government were signed by the Director-General of Health, Dr Ashley Bloomfield, and the Minister of Finance, Hon Grant Robertson, with the exception of the original agreement on 22 December 2020 which was signed by Robyn Shearer who was Acting Director-General of Health at the time.
