## Misuse of Drugs Amendment Act 2019: Interim Review

Portfolio Health

On 27 October 2021, the Cabinet Social Wellbeing Committee:

- noted that in 2019, amendments were made to the Misuse of Drugs Act 1975 (MoDA) to respond to harm caused by synthetic drugs to:
  - 1.1 affirm the ability of New Zealand Police to use discretion for personal possession and use of drugs, and require the consideration of whether, in addition to other relevant matters, health-based alternatives would be more beneficial to the public interest;
  - enable temporary class drug orders to be made allowing substances to be treated as class C controlled drugs;
  - 1.3 schedule two substances as Class A controlled drugs (AMB- FUBINACA and 5F-ADB);
- 2 **noted** that the Minister of Finance and Minister of Health sought an interim review on the implementation and impact of the amendments two years after their commencement, and a final review after five years;
- noted that while it is too soon to draw definitive conclusions, the interim review attached under SWC-21-SUB-0164 highlights encouraging signs that the amendments are having the desired effect;
- 4 **noted** that the interim review has recommended:
  - a range of policy and operational improvements to continue to deliver on the intent of the recommendations including:
    - 4.1.1 develop a common understanding of "health-based approaches" to drug harm reduction;
    - 4.1.2 review the evidence of effective outreach approaches for people using drugs harmfully to identify areas for service improvement;
    - 4.1.3 continually improve the MoDA referral pathways in line with international best practice so they are safe, evidence-based, accessible, and maximise engagement by those who need support to reduce drug harm;

- 4.1.4 understand and inform national and local referral pathways to health-based supports for people using illegal drugs, to facilitate easy access for people needing support to the most appropriate service or other support;
- 4.1.5 promote awareness of the national MoDA referral pathway, both with Police and alcohol and other drug service providers;
- 4.1.6 consider developing a cross-sector strategic framework to enhance health-based approaches to drug harm;
- 4.1.7 consider whether other referral pathways to mental health and addiction services require best practice improvements for effective outreach;
- 4.1.8 continue to explore opportunities to develop a package of solutions and target support services to Māori and vulnerable populations to address the issues associated with deaths and hospitalisations due to synthetic cannabinoids;
- 4.1.9 refine the existing Temporary Class Drug Order application process and clarity about the process be communicated to relevant stakeholders;
- 4.2 a range of data and analytical requirements for the full review scheduled for 2024;
- 5 **noted** that the Minister of Health intends to report back to Cabinet in 2024 on the outcomes of a final review of the amendments and their impact.
