Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health (the Ministry) on 9 May 2022 for:

"a list of the medicines we import showing their source of supply and import value with this sought under the Official Information Act."

Medsafe does not hold a list of medicines imported into New Zealand (except for controlled drugs that are licensed) and does not hold the corresponding source of supply or import value. Medsafe issues licences to import controlled drugs, pursuant to regulation 3(4) of the Misuse of Drugs Regulations 1977. The site of manufacture of all approved medicines is publicly available at: www.medsafe.govt.nz/regulatory/DbSearch.asp.

The table in Appendix 1 summarises the name of the controlled drug imported under a licence during 2021, and the exporting country/countries. This is released to you in full.

I have interpreted your request for the most recently available data, which is for 2021. Please note, this data includes all controlled drugs imported (with the exception of controlled drugs reference standards and analytical testing kits) and is not specific to medicines for therapeutic use (the list includes, for example, veterinary products and raw materials to be manufactured into finished products).

Pharmac and the New Zealand Customs Service may also hold some information about medicines imported. They can be contacted at: https://pharmac.govt.nz/about/contact/ and www.customs.govt.nz/contact-us/.
