Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to Manatū Hauora (the Ministry of Health) on 26 January 2023 for information regarding psychoactive substance licences. Manatū Hauora will respond to each part of your request in turn.

1. A copy of the license register

Please find attached in Appendix 1 a list of all licences issued by the Psychoactive Substances Regulatory Authority. This list includes both active and inactive licences but does not include interim licences (refer question 2), or applications in progress. Where information is withheld under section 9 of the Act, I have considered the countervailing public interest in release in making this decision and consider that it does not outweigh the need to withhold at this time.

Manatū Hauora is aware that the ESR licence number is incorrect, and we are actively working to update this.

2. Copies of the interim licenses and interim approvals issued by the Authority

A list of interim licences is provided in Appendix 1. This is a copy of the 'Interim Licences for Psychoactive Substances' page that was publicly available on the Ministry of Health website until November 2014, at which point it was replaced with the 'Licences for Psychoactive Substances' page. 3. Detail regarding the quantities of substances imported under interim licenses to import.

Please find attached in Appendix 1 the 'Register of Importation Notification for Psychoactive Substances'. Please note, the information which is deemed out of the scope of your request has been removed.

4. Detail regarding the quantities of substances surrendered, destroyed, exported, returned to the manufacturer under the recall provisions of the Act.

Manatū Hauora has identified an excerpt from a draft report within scope of this part of your request. The relevant excerpt is from a draft Psychoactive Substances Recall Report compiled in 2014, and is itemised in the table in Appendix 1.

5. Aggregate data from the stocktake reports provided to the Authority at the commencement of the interim license/ approval period and also at the conclusion."

Manatū Hauora does not hold aggregate data on stocktake reports from the period between the commencement of the interim licence/approval period and at the end of the interim period. Therefore, this part of your request is refused under section 18(g)(i) of the Act, as the information requested is not held by Manatū Hauora.

The requirement to provide the Psychoactive Substances Authority with information in the form of a stocktake report did not come into force until the Psychoactive Substances Regulations 2014 commenced. These regulations came into effect after the interim licence period had ended.

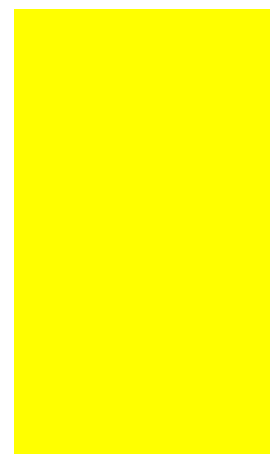
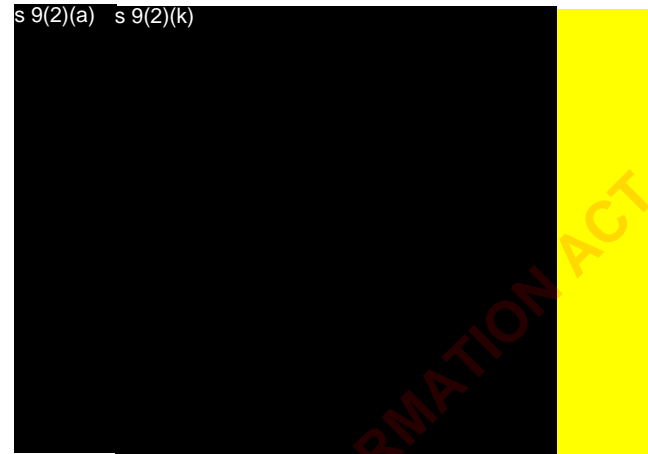
