Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to Manatū Hauora (the Ministry of Health) on 9 February 2023 for information regarding the Medsafe group's budget. I will respond to each part of your request in turn.

Can I have copies of Medsafe's income and expenditure for each of the past 5 years broken down as far as possible to align with activities such as compliance, new medicine approvals, changes to medicine labelling, pharmaceutical medicines, dietary supplement regulations psychoactive drugs, etc.

Information regarding the Medsafe group's income and expenditure since 2017/2018 is appended as Table 1. The revenue stated is third party revenue only. Medsafe also receives Crown funding for some activities such as, medical device regulation, however, this is not reported at operational level.

Can I also have the number of FTE staff for each of those years including the number with each of the following related qualifications: medical, nursing, pharmacy, natural health, Rongoa rakau (plant medicines)?

Please refer to the table below which outlines the staff FTEs for the Medsafe group, as at 30 June 2022 for the last five years. This does not include casual employees or employees seconded into the Ministry.

On 6 March 2023, Manatū Hauora contacted you in accordance with section 18B to of the Act, as your request was for a very large volume of information and may be refused under section 18(f) as it could not be made available without substantial collation or research. This is as this would require searching through the Human Resources files of every employee within Medsafe. On the same day you responded submitting a new request for information relating to the Therapeutic Products Bill, however, you did not refine the scope of the current request. Therefore, this part of your request is refused under section 18(f) of the Act.

As required under the Official Information Act 1982, Manatū Hauora will endeavour to respond to your new request regarding the Therapeutic Products Bill no later than 20 working days after the day your request was received.
