# Comment: The NZ Drug Foundation is a charitable trust that works to prevent and reduce drug-related harm in New Zealand

- For the past 30 years, the NZ Drug Foundation has been working to reduce and prevent drug harm in New Zealand through:
  - $\circ$  advocating for health and evidence-based drug laws and policies
  - o developing solutions and innovations to reduce drug harm
  - co-ordinating cross-sector groups to prevent and respond to acute harm
  - o delivering harm reduction services and advice to communities.
- The NZ Drug Foundation is focussed on supporting a health-based response to drug harm and is actively engaged in cross-sector substance use surveillance, along with promoting open and constructive relationships with all stakeholders working in this field.

#### Recent publications by the NZ Drug Foundation

- On 6 March 2024, the NZ Drug Foundation released a report titled 'Drug use in Aotearoa 2022/23'. This report focusses on the prevalence of substance use and describes the patterns of drug consumption in Aotearoa. It found a significant increase in cocaine use over the past year (a 93% increase<sup>1</sup>), however overall, the use of cocaine in New Zealand still remains low. The report also found that MDMA and methamphetamine use has decreased slightly.
- In October 2022, the NZ Drug Foundation was licensed by the Ministry as a drug checking provider and is now in its second year of delivering drug checking services. On 3 April 2024, the NZ Drug Foundation released their 2023 Drug Checking report, summarising the 2023 findings from drug checking clinics, festivals, and events.

#### NZ Drug Foundation's relationship with the health entities

- The Ministry has a positive working relationship with the NZ Drug Foundation. Following your approval for the Ministry to develop an overdose preparedness plan [H2024035468 refers], officials have met with the NZ Drug Foundation to inform the planning of this project.
- The NZ Drug Foundation is contracted by Health New Zealand | Te Whatu Ora (Health New Zealand) to deliver a range of national contracts including public health policy, supporting community action, information services, school-based initiatives, and drug checking services.
- Contracts the NZ Drug Foundation has with Health New Zealand include:

- Tūturu Service a school-based harm reduction service s 9(2)(b)(ii)
- Health Promotion s 9(2)(b)(ii)
- Licensed drug checking services s 9(2)(b)(ii)
- Coordination of acute drug harm responses and associated communities of practice <u>s 9(2)(b)(ii)</u>
- Drug health information service including 'The Level' harm reduction website <u>s 9(2)(b)(ii)</u>
- ReWired reducing drug-related, sexual health and mental health harms for gay and bisexual men who use methamphetamine s 9(2)(b)(ii)



 However, Health New Zealand share that they have advised all four funded drug checking providers that it is anticipated their contracts will be rolled over for an additional 12 months, through to 30 June 2025.

#### NZ Drug Foundation priorities

- In December 2023, the NZ Drug Foundation provided your office with a briefing outlining its priorities to prevent drug harm in New Zealand. These include:
  - o emerging risks and increasing volatility in the illicit drug market
  - o preventing overdose deaths
  - alcohol and other drug workforce
  - o mutual aid and peer support networks
  - response to methamphetamine
  - preventing harm through diagnosis and treatment of ADHD
  - innovations in psychedelic-assisted therapy.

#### **Other NZ Drug Foundation priorities**

- As signalled in the previous aide-mémoire for the NZ Drug Foundation's AGM [H2023033290 refers], there are some other topics of interest to the NZ Drug Foundation that may be raised in the meeting. These include:
  - seeking commitments from the government to bulk purchase Nyxoid (an unfunded nasal spray form of naloxone). The NZ Drug Foundation put forward an application for Pharmac to fund Nyxoid. A decision is expected later this year



- establishing a pilot for a safe consumption space/overdose prevention centre to provide a safe, clean space for people to bring their own drugs to use, in the presence of trained staff (in an effort to reduce harm, prevent accidental overdoses, and reduce the spread of infectious diseases)
- setting up a specific National Mortality Review Committee that explores deaths from substances and overdoses.
- The NZ Drug Foundation has also signalled priorities related to pursuing a review of the Misuse of Drugs Act 1975 to decriminalise the use of illicit drugs.
