#### **Purpose of report**

1. This briefing seeks your approval of an updated joint work plan between the Ministry of Health | Manatū Hauora (the Ministry) and Health New Zealand | Te Whatu Ora (HNZ) to address workforce challenges.

#### We have provided an updated joint work plan for your approval

- 2. On 1 March 2024, we provided you with a draft joint work plan between the Ministry and HNZ [H2024036384 refers]. This work plan outlined short-, medium-, and long-term actions the Ministry and HNZ are taking to address workforce challenges by improving how we:
  - a. recognise and develop the skills and capabilities we need to meet health needs now and in the future
  - b. value and incentivise the workforce to improve retention and how the workforce is utilised
  - c. provide regulatory settings that are flexible and uphold patient safety, allowing the workforce to operate in more efficient and innovative ways.
- 3. On 8 April 2024, we received your feedback from your office that the joint work plan needs to be more aligned with the coalition Government's priorities. We have provided an updated version of the joint work plan for your approval at **Appendix One** to address your feedback.

#### **Next steps**

4. We will keep you updated of progress through our weekly report to you and advice at key decision points. HNZ will continue to provide you with advice on the development of its Health Workforce Plan 2024/25.
