Smokefree Environments and Regulated Products (Vaping) Amendment Bill: Approval for Introduction

Portfolio

Associate Health (Hon Jenny Salesa)

On 19 February 2020, the Cabinet Social Wellbeing Committee, having been authorised by Cabinet to have Power to Act [CAB-20-MIN-0038]:

- noted that a category 2 priority is being sought for the Smokefree Environments and Regulated Products (Vaping) Amendment Bill on the 2020 Legislation Programme (must be passed in 2020);
- 2 **noted** that the Bill will improve the regulation of vaping and smokeless tobacco products and seeks to strike a balance between protecting young people from the risks associated with these products and supporting smokers to switch to much less harmful alternatives;
- approved the Smokefree Environments and Regulated Products (Vaping) Amendment Bill [PCO 20368/15.0] for introduction, subject to the final approval of the government caucuses and sufficient support in the House of Representatives;
- 4 **agreed** that the Associate Minister of Health (Hon Jenny Salesa) may authorise minor and technical changes to the Bill ahead of its introduction;
- agreed that the Bill be introduced before the end of February 2020;
- agreed that the government propose that the Bill be:
 - 6.1 referred to the Health Committee for a period of three-months;
 - 6.2 enacted by 31 July 2020.
