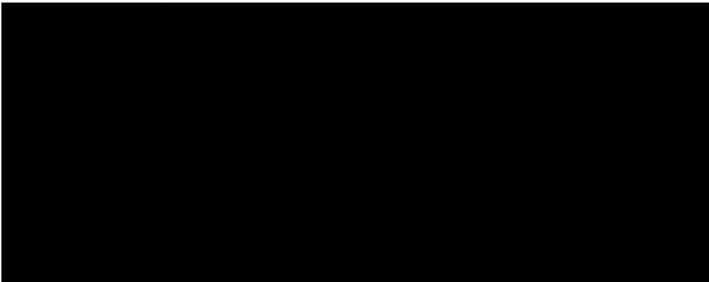

### Request for official information
