Thank you for your request under the Official Information Act 1982 (the Act) on 5 January 2021 for:

As of 4 February 2021, the Medicinal Cannabis Agency (the Agency) has received 44 applications for a New Medicinal Cannabis Product since 1 April 2020.

In response to parts a through c of your request, please refer to Table One overleaf. Please note that some information has been withheld under section 9(2)(b)(ii) of the Act, as it is commercially sensitive. This includes all applications received by the Agency that are currently under assessment, undertaking an initial check for completeness, have not been accepted or have been withdrawn. The information provided in Table One is based on the information submitted in the applications and is not indicative of the trade name, active ingredients or strength of active ingredients that would satisfy the requirements of the minimum quality standard.
