Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to Manatū Hauora (the Ministry of Health) on 19 October 2022 for information relating to section 5 of the End of Life Choice Act 2019. Each part of your request is responded to below.

Who is charged with the decision of whether an individual is experiencing 'unbearable suffering'? Please provide a list of diagnoses/conditions that meet this criterion if such a list exists.

The attending medical practitioner and independent medical practitioner separately decide if a person meets the eligibility criteria for an assisted death by using their knowledge and experience combined with the information from the person applying. This includes whether the person is 'experiencing unbearable suffering that cannot be relieved in a manner that the person considers tolerable.' A full list of eligibility criteria is available on our website here: www.health.govt.nz/our-work/life-stages/assisted-dying-service/assisted-dying-information-public/assisted-dying-eligibility-and-access.

Your request for a list of diagnoses/conditions that meets the definition of 'unbearable suffering' is refused under section 18(e) of the Act, as the document requested does not exist.

What is New Zealand's official definition of 'terminal illness'? No such expansion is proffered in the Act. Please provide a list of diagnoses/conditions that meet this criterion if such a list exists.

Your request for this information is refused under section 18(g)(i) of the Act as the information requested is not held by Manatū Hauora or any other agency subject to the Act. You may wish to refer to publicly available medical definitions of this term.

Your request for a list of diagnoses/conditions that meets the definition of 'terminal illness' is refused under section 18(e) of the Act, as the document requested does not exist.
