Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health (the Ministry) on 17 May 2022 for information about the World Health Organization's (WHO) Global Pandemic Treaty. Please find a response to your request below.

"Documents/reports regarding the WHO Global Pandemic Treaty (also known as the International Agreement on Pandemic Prevention, Preparedness and Response; the Global Treaty on Pandemic Preparedness and the International Pandemic Treaty)"

WHO Member States, including New Zealand, jointly agreed to begin negotiating a new treaty (or instrument) at a special session of the World Health Assembly in November 2021. A pandemic treaty or instrument was a key recommendation of the Independent Panel for Pandemic Preparedness and Response, to help improve the global community's ability to respond to future pandemics. The negotiations towards a new treaty or instrument are being taken forward via an Intergovernmental Negotiating Body (INB) involving all WHO Member States including New Zealand. As part of the INB process, Member States will jointly determine what actions will be required to better prevent, prepare and respond to a future pandemic. New Zealand sees the establishment of the INB as an important step towards preparing the world for future health emergencies and ensuring that a global health crisis of this magnitude does not occur again. Governments are working towards an outcome by the 77th World Health Assembly in 2024: www.who.int/about/governance/world-health-assembly.

Please note that the Ministry is proactively releasing joint advice produced with the Ministry of Foreign Affairs and Trade (MFAT) that relates to negotiations towards a new pandemic treaty or instrument in the coming weeks. As such, your request for documents regarding the WHO global pandemic treaty is refused under section 18(d) of the Act, as the information requested will soon be made publicly available.
