Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to Manatū Hauora (the Ministry of Health) on 7 March 2023 for information regarding Pasifika staff at the Ministry. Each part of your request is responded to below in turn.

1. Number of Pacific peoples employed in the Ministry of Health in 2014 to 2022. The list would provide specific racial background of Pacific employees such as Samoans, Cook Islands Maori, Tokelauans, Tongans and people of Niue, Tuvalu and Kiribati ethnicities. Staff information must also specify the gender, age group and disability background.

Please find in Appendix 1 a document detailing the information requested. This has been released to you in full.

- 2. Copy of the latest Human Resource Plan
- 3. Inclusiveness and diversity policy documents (guidance to employ a diverse front-line staff or policies to deliver inclusive front-line services).
- 4. Other documents that may help us understand how your organisation is working towards promoting ethnic, gender and disability representativeness in the front-line services.
- 5. Please consider adding to the OIA request, information about the main duties of front-line or front-desk in your organization. I would appreciate if I could get copies of the post descriptions for the front-line staff.

As you were advised on 16 March 2023, parts 3 to 5 of your request have been transferred under section 14(b)(ii) of the Act to Te Whatu Ora – Health New Zealand as they are the agency that employs front line health care workers. You can expect a response from Te Whatu Ora in due course.

On 16 March 2023 you also clarified part 2 of your request. You stated:

In addition to the OIA request, I would also need the most update Workforce Plan for the Ministry of Health. Below is the description of the information I'm seeking from your good office:

The Ministry of Health may have a different template or style of doing a Workforce Plan. I also understand the limitation to provide personal information about employees. However, what I am expecting to find out is detailed information of your Ministry's practice or strategy to provide human resources for its registered Full-time Equivalent positions/jobs. Hence, I am expecting information that shows the total number of FTE positions within the Ministry of Health and whether they are occupied or vacant (including Police and non-Policeman). I am also seeking the Ministry of Health plan to recruit for existing vacant positions and to fill-in vacant positions for the next 3 years based on retirement, termination and so forth.

As of 28 February 2023, Manatū Hauora has 727 filled positions, 213 available vacancies (however these are subject to business planning and budgeting approvals being met), and 89 unavailable vacancies (roles that are held vacant due to the substantive incumbent being on leave without pay, parental leave, or a secondment).

All of the above figures are full-time equivalents.

The Ministry does not have a workforce plan that details how these vacant positions are to be filled over the next 3 years. Vacancies are filled as each directorate prioritises its budget and business plan for the year.
