## Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to Manatū Hauora (the Ministry of Health) on 13 March 2023 for information regarding specialist vape retailers (SVR).

Manatū Hauora has a Specialist Vape Retailer Register. This shows all the approved vaping premises (AVP) and approved internet sites (AIS) that are allowed to operate as a specialist vape retailer in Aotearoa New Zealand, as well as the ones who no longer have a license. The register provides the physical address of each AVP or the website URL of each AIS, as well as the date the applications were approved. Any applications that are approved will automatically be updated onto this register.

Each part of your request is responded to below. All figures provided are as of 13 March 2023.

How many Specialist Vape Retailer (SVR) applications have been made to the Vaping regulatory Authority in 2023?

In order to operate as a specialist vape retailer in Aotearoa New Zealand, applicants must have one specialist vape retailer application for their business approved and at least one approved vaping premises application which is in relation to a specified retail premises. Additionally, applicants can also submit approved internet site applications for a specified internet site.

In 2023, the Vaping Regulatory Authority have received:

- 68 specialist vape retailer applications
- 81 approved vaping premises applications
- 9 approved internet site applications.

Please note, these figures do not include applications that have not been paid for or have been withdrawn by the applicant.

How many of the above have been approved?

Based on the above applications:

- 23 specialist vape retailer applications have been approved
- 40 approved vaping premises applications have been approved
- 9 approved internet site applications have been approved

It is noted that the remaining applications do not reflect the number of declined applications, as the assessment of many applications received in 2023 are still ongoing.

Furthermore, these figures are solely based on the applications received by the Vaping Regulatory Authority in 2023 and do not reflect the total number of applications that have been approved in 2023.

Can I please have a breakdown to the approved applications by month?

The information you have requested is provided below in Table 1.

Can I please have the region and the city district of the approved locations/ retailers?

Please refer to the Specialist Vape Retailer Register, which outlines the physical address of all approved vaping premises in Aotearoa New Zealand. As such, this part of your request is refused under section 18(d) of the Act, as the information requested is publicly available.

Can I please have the number of approved applications made in the years 2022, 2021 and 2020?

The information you have requested is provided below in Table 2.

Note that as retailers could only apply to become a specialist vape retailer from 11 August 2021, there were no applications approved in the year 2020.

For the years above can i please have a regional break down (if possible city & district too)?

Manatū Hauora does not hold information on the number of specialist vape retailers by region. As such, this part of your request is refused under section 18(g)(i) of the Act, as the information requested is not held by Manatū Hauora and there are no grounds for believing it is held by another agency subject to the Act. Please refer to the Specialist Vape Retailer Register mentioned above, which outlines the physical address of all approved vaping premises in Aotearoa New Zealand.

If possible, can I have a monthly breakdown of approved applications?
