Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health – Manatū Hauora (the Ministry) on 27 November 2023 for information regarding Government agency branding and websites. Each part of your request is responded to below.

All costs associated with the creation your agency's brand/logo. Including, but not limited to consultation, design, advertising, introducing the brand change, etc since 2017.

A timeline of all branding changes, and the corresponding total cost of each change.

The Ministry has not rebranded in the past 5 years. In 2021/22 the Ministry made some minor updates to its visual identity, which was undertaken in-house within baseline with no additional cost. This included modernising the logo by updating the colour scheme and repositioning the Ministry's name. There was no public consultation on this change.

Although there was no additional cost in the 2021/22 change, you may be interested in the information on the brand that is publicly available in the June 2023 Health Select Committee Questionnaire, which has been published on the Parliament website. Please refer to question 20:

The cost and names of all sub-brands or logos of your agency and when these were created or changed. For example, Te Whatu Ora has the smokefree 2025 sub-brand for their Smokefree 2025 campaign and Waka Kotahi has the Road to Zero sub-brand.

As part of the establishment of the Public Health Agency – Te Pou Hauora Tūmatanui (PHA) in the 2021/22 financial year, there were costs associated with the development of a visual identity and related design work.

The PHA was established on 1 July 2022 to lead on all public health and population health policy, strategy, regulatory, intelligence, surveillance and monitoring functions as part of the wider Ministry and wider health reform environment.

Initial visual identity and design work was commissioned by the interim PHA director in December 2021 through design agency Ira, at a cost of \$16,555.25.

This initial exploratory identity and design work shaped the final brand development work, which was completed in house at no additional cost. This work was completed in 2023.

No other branding work has been commissioned since 2017.

Ongoing costs associated with the development and upkeep of the agency's websites. This includes, but not limited to consultation, design, advertising, rolling out any website changes/updates, etc. Please give data for each year since 2017, along with the projected costs going forward.

In 2022/23, the Ministry commenced a website redevelopment project for our main website (<u>www.health.govt.nz</u>). This work is targeted for completion in 2023/24. This project will replace the current website which is now 12 years old and built on a platform (Drupal 7) that will reach its end of life in Jan 2025. Total costs for the website redevelopment project work completed in 2022/23 were \$297,000. Budgeted costs for 2023/24 are \$1,683,000.

Once completed the ongoing annual costs of maintaining the new website are provided in table 3 below.
