Pae Ora (Disestablishment of Māori Health Authority) Amendment Bill: Approval for Introduction

Portfolio Health

On 22 February 2024, the Cabinet Legislation Committee:

- 1 **noted** that the Pae Ora (Disestablishment of Māori Health Authority) Amendment Bill (the Bill) seeks a category 2 priority on the 2024 Legislation Programme (must be passed in 2024);
- 2 **noted** that the Bill disestablishes the Māori Health Authority and redistributes its functions within the publicly funded health system;
- 3 **approved** the Pae Ora (Disestablishment of Māori Health Authority) Amendment Bill [PCO 25943/2.3] for introduction, subject to the final approval of the Government caucuses and sufficient support in the House of Representatives;
- 4 **agreed** that the Bill be introduced on 27 February 2024;
- 5 **noted** that the proposed introduction date will meet the 100-day commitment to introduce legislation by 8 March 2024;
- 6 **agreed** that the government propose that the Bill be:
 - 6.1 progressed through urgency;
 - 6.2 enacted by 30 June 2024.
