“This report presents the findings from the Saving Babies Lives Project Impact and Results Evaluation (SPIRE) conducted by the Tommy's Stillbirth Research Centre at the University of Manchester, commissioned by NHS England in May 2016. [Clinical pharmacists in general practice: pilot scheme evaluation](#)

“This evaluation report showed that clinical pharmacists significantly increase patient appointment capacity and reduce pressure on GPs. More than 490 clinical pharmacists were placed in over 650 practices across England in the pilot project which supports the aim of having over 2,000 clinical pharmacists working in general practice by 2020/21 – a ratio of

one per 30,000 patients. The research team investigated the work of the newly created clinical pharmacist roles from the perspectives of the pharmacists, those working immediately with them in their roles, professional stakeholders and patients.” *Source: NHS England*

“Recommended intake levels for nutrients and other dietary components were designed initially to prevent nutrient deficiency diseases in a given population, and the original methodological approach used to derive intake values did not include consideration for other applications. However, with the increasing globalization of information and the identification of a variety of factors specific to different population subgroups (e.g., young children and women of reproductive age) that influence their nutritional needs, there has been increasing recognition of the need to consider methodological approaches to deriving nutrient reference values (NRVs) that are applicable across countries and that take into account the varying needs of different population subgroups.” *Source: National Academies Press*

Behavioural research suggests that this will remain the case even if people are better informed about how the social care system works, the choices they may face and the costs they may incur. So it is important that the design of the social care system reflects this and can respond quickly and effectively at times of crisis.
