

# High Use Health Card Information

## Criteria required to qualify for a High Use Health Card

To qualify for a High Use Health Card, a patient must have received at least 12 health practitioner consultations within the last 12 months for a particular ongoing medical condition(s). Evidence of this may be required.

To qualify towards a High Use Health Card, a health practitioner consultation must comply with the provisions of the Health Entitlement Card Regulations 1993 and its amendments ([www.legislation.govt.nz](http://www.legislation.govt.nz)).

Services fully, or partially reimbursed under the Injury Prevention, Rehabilitation and Compensation Act 2001, do not qualify towards a High Use Health Card.

## How to apply for a High Use Health Card

All High Use Health Card applications must be submitted by a medical/general practitioner.

Please check all patient details are completed correctly before submitting the application to the Ministry of Health, Whanganui.

Both the medical/general practitioner, and patient (or guardian), must sign the application form on visit 12. All 12 patient visits must be within 12 months of the date the medical/general practitioner has signed the application form.

The medical/general practitioner sends the completed High Use Health Card application form to the Ministry of Health for processing.

Medical/general practitioners will be advised of the acceptance, or rejection of an application. If the application is approved, the High Use Health Card is sent to the patient.

## Renewal applications for a High Use Health Card

Once the patient's High Use Health Card expires the medical/general practitioner must submit a new application. The application cannot be made more than 30 days before the current card expires.

Each month, letters are generated, and sent to medical/general practitioners informing them of their patients with High Use Health Cards due to expire.

## Entitlement dates

The entitlement date of a High Use Health Card is the day following the last consultation date on the application form.

If the application is a renewal, the card will commence the day after the expiry date of the previous card, or the last consultation date of the application form; whichever is the latest. A High Use Health Card is valid for one year.

## Lost/stolen cards

If a High Use Health Card is lost, or stolen, the patient should contact the Ministry of Health on **0800 243 666** as soon as possible. For security reasons, a new card will be issued with the same expiry date.

## Cardholder deceased

If the patient dies, please notify the Ministry of Health in writing to ensure no further correspondence is sent to the patient's address.
